
NOTES : Areas under Zone 'A' :- Calcutta Corporation & Municipalities of Dum Dum, North Dum Dum, Barrackpore, South Dum Dum, Garia, Bhatpara, Naihati, Halishahar, Kanchrapara, South Suburban, Garden Reach, Budge Budge, Barranagar, Kamarpur, Panhati, Khardah, Tilagarh, North Barrackpore, Howrah, Bally, Uttarpara, Kotrong, Konnagar, Baidyabati, Chandannagore, Banesbaria, Chinsurah, Rishra, Serampore, Bhadravtar, Champdani, the District of Darjeeling and Municipal Areas of Jalpaiguri district, Asansol & Durgapur Sub-divisions of Burdwan district all newly covered municipal and corporation areas, Haldia, Salt Lake & Pujali Notified Areas and the areas of Farakka, Dankuni, Majuli Thermal Plant, Kolaghat and Kharagpur. The Farakka area includes the entire work site of the contractors engaged by National Thermal Power Corporation, Farakka Super Thermal Power Plant or any other authority in connection with the Farakka Barrage and National Thermal Power Projects including the township area.

Zone B :- The rest of West Bengal

- 1) The daily rates of Minimum Wages shall be computed by dividing the total monthly wages by 26 and shall be rounded off to the nearest paisa.
- 2) The overtime rate shall be double the ordinary rate.
 - a) Workers employed on high rise building over 30 ft. in height or four floors, also employed on tunnel work shall be paid 20% of the minimum wages fixed under the notification for the appropriate category as extra wages.
 - b) "Unskilled Work" means work which involved simple operation requiring little or no skill or experience on the job.
 - c) "Semi-skilled Work" means work which involved some degree of skill or competence acquired through experience on the job and which is capable of being performed under the supervision or guidance of a skilled employee and includes unskilled supervisory work.
 - d) "Skilled Work" means work which involved skill or competence acquired through experience on the job or through training as an apprentice in a technical or vocational institute and the performance of which calls for initiative and judgement.
 - e) "Highly Skilled Work" means work which calls for high degree of perfection and full competence in the performance of certain tasks acquired through intensive technical or professional training or practical work experience for long years & also required a worker to assume full responsibility for the judgement or decisions involved in the execution of these tasks.




